# FALL 2024 DELIVERY MODE AND VACATIONS

The fall 2024 term is 14-weeks in duration. Attendance in all lectures and labs is mandatory. ALL classes AND labs in the veterinary technician program are face-to-face and on-site at Sheridan College's Davis campus (Steeles & McLaughlin Road in Brampton). Lectures and labs start September 3. Please come to your classes ON TIME and prepared to work. To help create a safe learning space for all students, the program does not record lectures and labs.

**Vacations during the academic term**-The program **DOES NOT** recommend that you book a personal vacation during the semester. Due to the practical nature of the program, we **WILL NOT** reschedule assessments (lecture or lab) to accommodate personal vacations taken during teaching weeks, and will result in a grade of 0 for that assessment. Please plan accordingly.

# <u>PLACEMENT & VACCINATIONS – VERY IMPORTANT – READ CAREFULLY!</u>

Prophylactic vaccination against the rabies virus is MANDATORY for all students entering the Veterinary Technician program. By now, you should have completed the Intent to be Vaccinated Form (link sent via email to all incoming students). The Veterinary Technician program in collaboration with the Davis campus Health Center team is requesting information to help prepare you for your Rabies vaccination. If you have not done this,



please do so ASAP as we need this information to ensure sufficient quantities of vaccine are ordered for the fall term

Instructions for how to get your first vaccine at Sheridan College will be provided by the Davis Health Center team during the program orientation on August 30. The **approximate** cost is \$187.00 PER DOSE and students require 3 doses. Sheridan does not directly bill to insurance companies; a receipt will be provided. After completion of the rabies vaccination series, a blood sample is collected to check immunological response (i.e., titre) at no cost by the Davis Health Centre nurses and/or physicians. Students who are already vaccinated against the rabies virus can get a rabies titre (covered by OHIP) done after July 1 through their regular physician or the Davis Health Centre. This will ensure that your titre results are valid throughout the placement duration. Rabies vaccines can also be obtained through some family doctors and travel clinics, but they may be more expensive.

Students in the veterinary technician program are required to find their own placement in a regular small animal veterinary hospital/clinic staring in semester 1. Your placement supervisor must be an RVT or DVM. The clinic you choose for your placement cannot be your place of employment. Confidential documents required for field placement are reviewed by Synergy Gateway, a 3<sup>rd</sup> party company for document verification. The cost to use Synergy is approximately \$50.00/year and is payable at the time when you upload your documents. More information will be provided during orientation and in your first SCIE10123 lab.

#### **ATTIRE**

Sheridan specified coloured scrubs and name tag are MANDATORY attire for ALL laboratory sessions/classes and off campus excursions. A special pick-up time for all vet tech students has been arranged at the bookstore on Orientation Day (August 29, 2024) from 10:45-11:45 am. Scrubs must be Royal Blue in colour and can be picked up in the Sheridan Bookstore with your student ID. Each student will receive 2 sets of scrubs, the cost of which is already included in your kit fees. Please take your **Onecard** to the Bookstore to pick-up your sets. A sizing chart has been provided with this letter.

A Sheridan nametag will be issued to you to identify you as a Veterinary Technician student, and you will receive a high-quality stethoscope as part of your program kit. Your kit also contains items you will require for certain classes. Your instructors will let you know what you are required to bring to their class. Kits will be distributed in week 1 or 2 in one of your classes/labs.

Closed-toe shoes with a non-slip sole are MANDATORY (Crocs or similar footwear are not permitted), long necklaces and dangly earrings are not permitted, and long hair must be tied back. You will not be permitted to participate in a lab if you are not appropriately attired. This includes exams and assessments. Individual instructors may also have additional requirements for their specific courses, which must be adhered to.

Students are expected to maintain a clean, tidy professional image while on campus and while out on placement. Please note that placement facilities reserve the right to enforce dress code requirements that meet their professional expectations.

#### **TIMETABLES**

Timetables in the veterinary technician program are pre-assigned based on blocks. Therefore, the only course you need to pick in term 1 is a general education elective (details provided below). Students must have paid their full-time tuition deposit to receive a timetable. Lecture and lab sections for term 1 may be swapped IF there is space. Sections that are at capacity (i.e. full) will NOT be listed on the add/drop/swap portal. We anticipate timetables to be released early August (approximately in the second week) and add/drop/swap will open the following week. Please note that lab sections have a maximum capacity which we are unable to exceed. Changes to your timetable can be made up to day 10 of the fall term. Adjustments to your timetable can be made on Sheridan Central under the myOTR tab.

For the veterinary technician program, timetable questions are triaged first by Sheela Iyer (Program Coordinator & Academic Advisor). If you have questions about your schedule, please contact Sheela **AFTER August 12**, **2024** (<a href="mailto:sheela.iyer@sheridancollege.ca">sheridancollege.ca</a>).

You will be required to select General Education courses in your 1st, 3rd and 4th semesters. It is highly recommended that you select courses that are offered online, due to current program map requirements to accommodate field placement. You will be required to select and enroll in your General Education course. Instructions enrolling General Education courses can for in http://myotr.sheridaninstitute.ca/electives.html. Please email generaleducation@sheridancollege.ca if you have questions about the courses or how to obtain advanced standing for prior credits from another educational institution. Your timetable will contain a general education placeholder that you will need to swap for a course. Students who have advanced standing for the term 1 general elective can ignore the placeholder. It will be removed by the Office of the Registrar after day 10 of the fall term.

You will also be enrolled in an English Communications class – either COMM19999 or COMM19997. The results of your language assessment will determine which course you are enrolled in. If you are enrolled in COMM19997 you will be required to take COMM19999 in your second semester. If you do not see either of these courses on your schedule, please confirm that you have completed the language assessment and then go to the OTR (Office of the Registrar) to have it added. You cannot graduate without having completed COMM19999.

If you wish to apply for Advanced Standing for your general education requirement(s), you must have your application submitted within the first 2 weeks of the semester, although it is encouraged to begin the process prior to the start of the semester. All core veterinary technician program course submitted for Advanced Standing must have a passing grade of 60% or higher, have been taken within 5 years, and is at least 80% equivalent in curricular content and programmed hours to the Sheridan course. # **ADDITIONAL DUTIES & ACTIVITIES**

Reasonable additional duties may be assigned on a course-by-course basis, which may include lab monitors, and lab set-up/take down, and students will be expected to complete and manage these duties as an integral part of their education. Students will participate in off campus activities and/or laboratory sessions and will be responsible for their own transportation to and from these sites (i.e., for labs conducted at Brampton Animal Shelter). Most sessions take place in the Brampton/Mississauga area and are accessible by public transportation. Attendance is mandatory.

#### **BOOKS & SUPPLIES**

A booklist has been provided with this letter. You may also contact the Campus Bookstore for assistance. Consider using their online portal to order your books which you can then pick up on August 29 (10:45-11:45 am) when you are at Sheridan for Orientation. Supplies for labs will be provided to you in your student kits and during classes. While a laptop computer is not required for this program it is highly recommended.

You will require a basic (non-programmable) calculator for a number of your courses, beginning with MATH10688. Cell phones, tablets, and smart watches are not permitted to be used as a calculator during classes and/or quizzes, tests, or exams for any course.



#### **ONECARD** – campus access card

New incoming full-time students are required to upload a photo for their **Onecard.** Once enrolled at Sheridan you will automatically receive a link to your Sheridan email account to upload a photo.
